## AFTERSCHOOL CLUB REGISTRATION AGREEMENT

I understand this registration form is a contract for my child's care for specific days and weeks and that I am liable for the cost, regardless of whether or not my child attends. I agree to pay JLR Enterprises Inc./AFTERSCHOOL CLUB® Fees. I understand there is no credit for illness, absences, vacation, or holidays. Further, I am responsible for payment of all days and weeks that I have indicated or added at a later date. I am the legal parent or guardian and therefore I have the authority to enter into this agreement. I give permission for my child to ride to and from Afterschool Club in buses and company or personal vehicles. I agree to provide a booster seat for my child if he/she is under eight years old. My child has permission to participate in Afterschool Club field trips. Afterschool Club has my permission to use my child's photo in activities for publication.

I grant JLR Enterprises Inc./AFTERSCHOOL CLUB permission to administer emergency treatment to my child. This may include, but is not limited to, emergency first aid, local rescue squad or local hospital/trauma center.

Payments are due no later than the first day of attendance for the payment period. The registrant agrees to make payment to JLR Enterprises Inc./Afterschool Club no later than the due date or pay an additional ten dollars (\$10.00) per late payment. Returned checks or declined credit card payments will incur an additional twenty-nine dollar (\$29.00 fee and administrative charge), plus the late fee if payment is not received in full by the due date.

The registrant understands and agrees to be responsible for all costs incurred with collecting any debts more than 30 days past due, including but not limited to, fees for late payment, returned payments, uncollected payments, court costs, filing fees, attorneys' fees.

I understand that payment is due prior to starting the spring break sessions. I understand that if not paid in full prior to attending, my child will not be able to attend spring break sessions.
